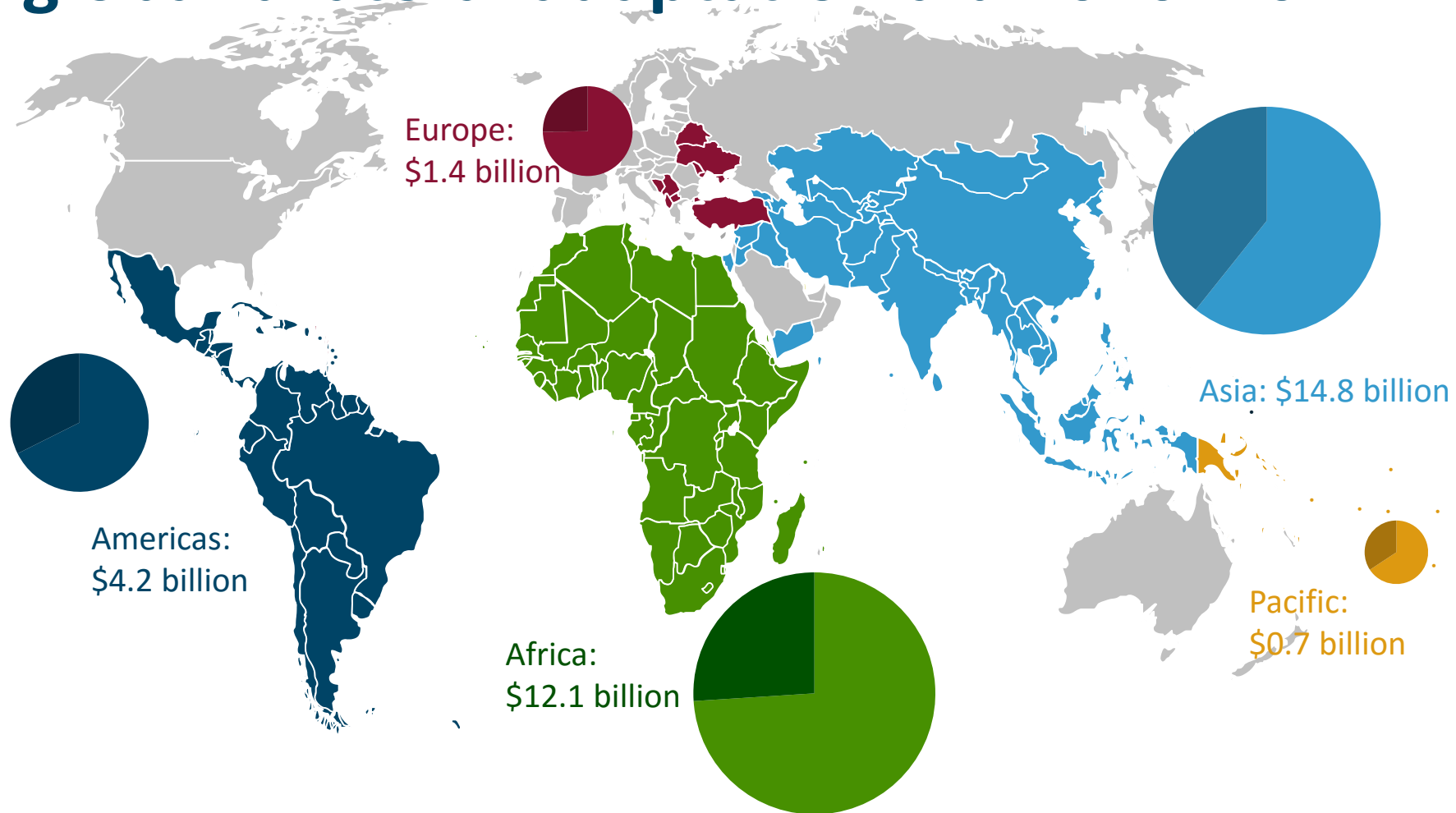

overview

mapping of adaptation aid to Pacific Island Countries (PICs)

- between 2010 and 2014 as reported in OECD CRS*
- focus on
 - overall **volume**
 - main **providers**
 - **distribution** across recipients (total, per capita, percent)
 - distribution across sectors
 - who gives to whom?

key findings

- adaptation aid to PICs...
 - ... is a **small share** of global adaptation aid and of total development aid to the region;
 - ... comes from a **few bilateral donors**;
 - ... is **distributed unevenly** among PICs (total volume, per capita in percent of overall development aid).

recommendations

to support adaptation in PICs, we need...

- **scaled-up and predictable** adaptation aid;
- **clearer** definitions and **reporting** guidelines;
- monitoring of adaptation aid **within recipient countries.**

data source

OECD aid data

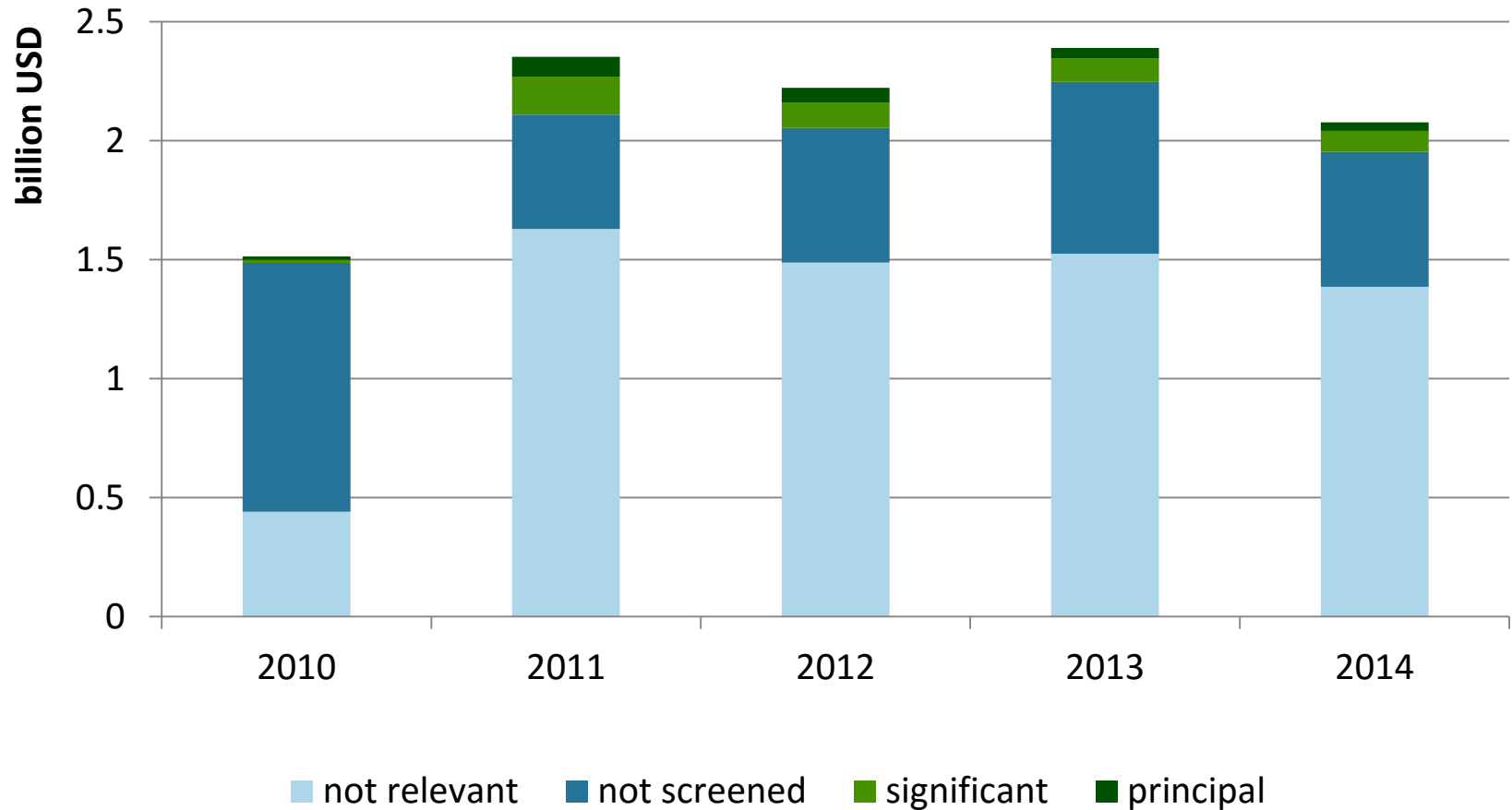
- “**Rio Marker**” for adaptation since 2010
- projects where adaptation is the **principal** or a **significant** objective

a note of caution

- donors’ own classification
- problems with **over-reporting*** and mislabeling
- commitments, including loans and grants

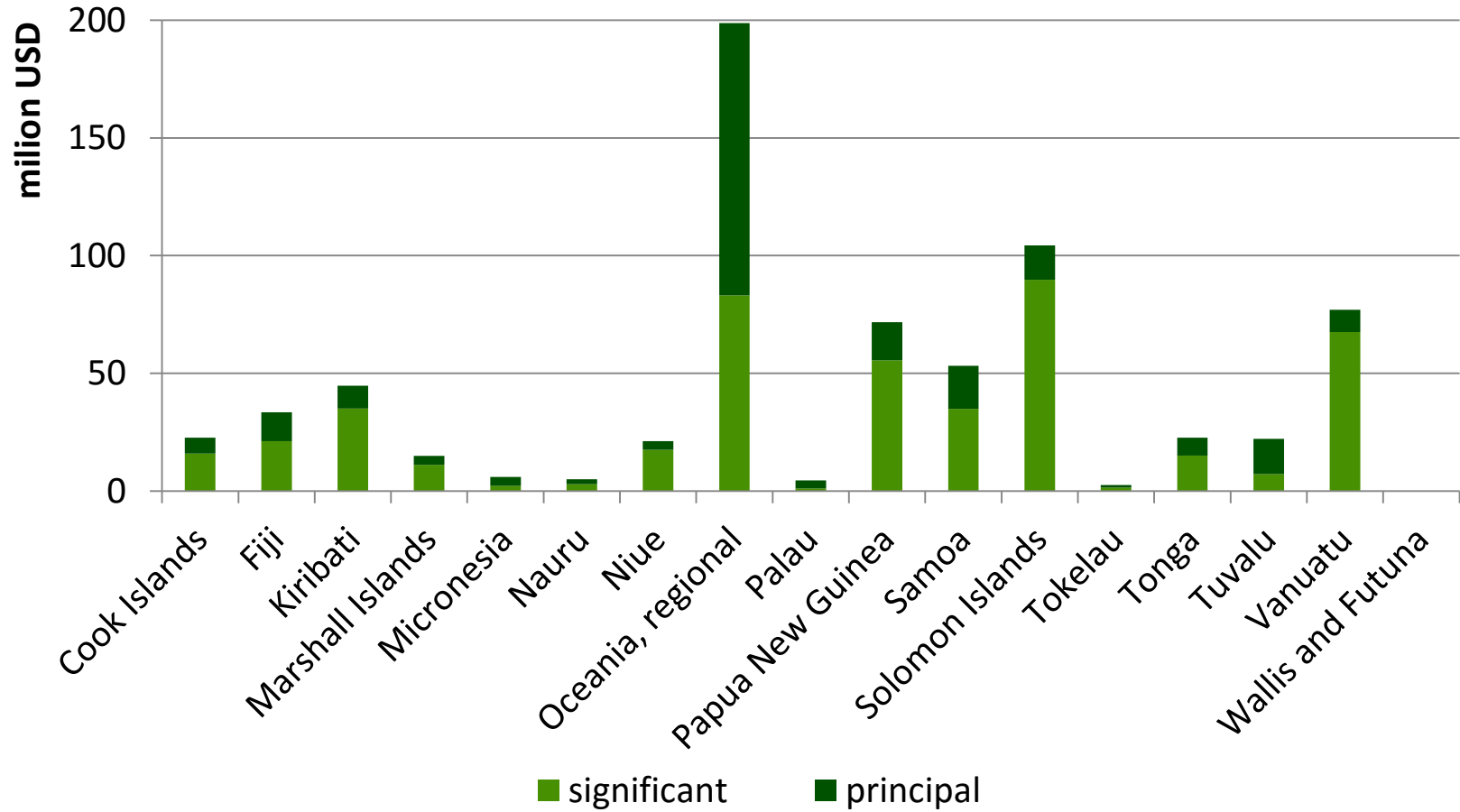

total adaptation aid to PICs



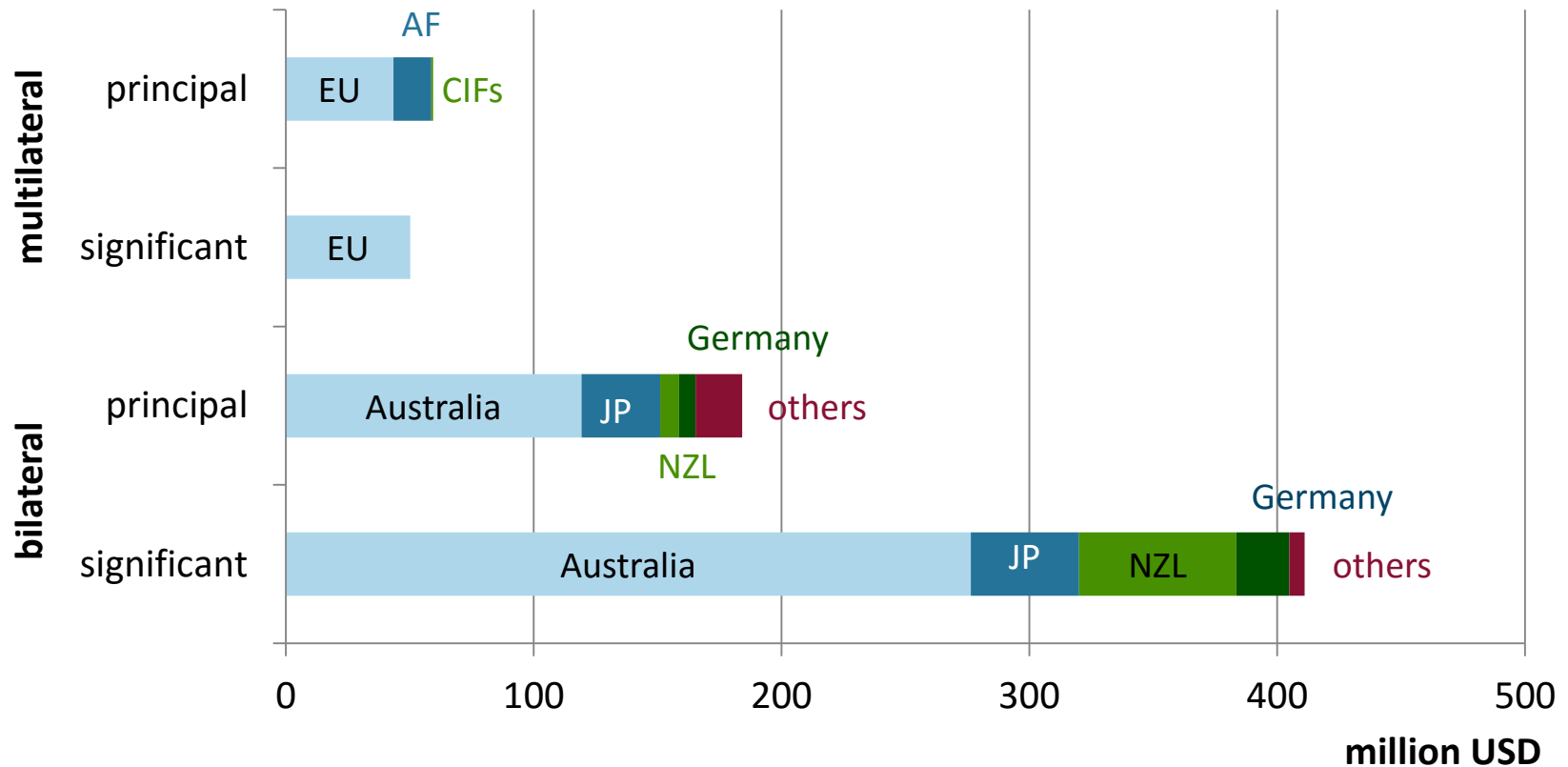

 - monitoring of adaptation aid **within recipient countries**

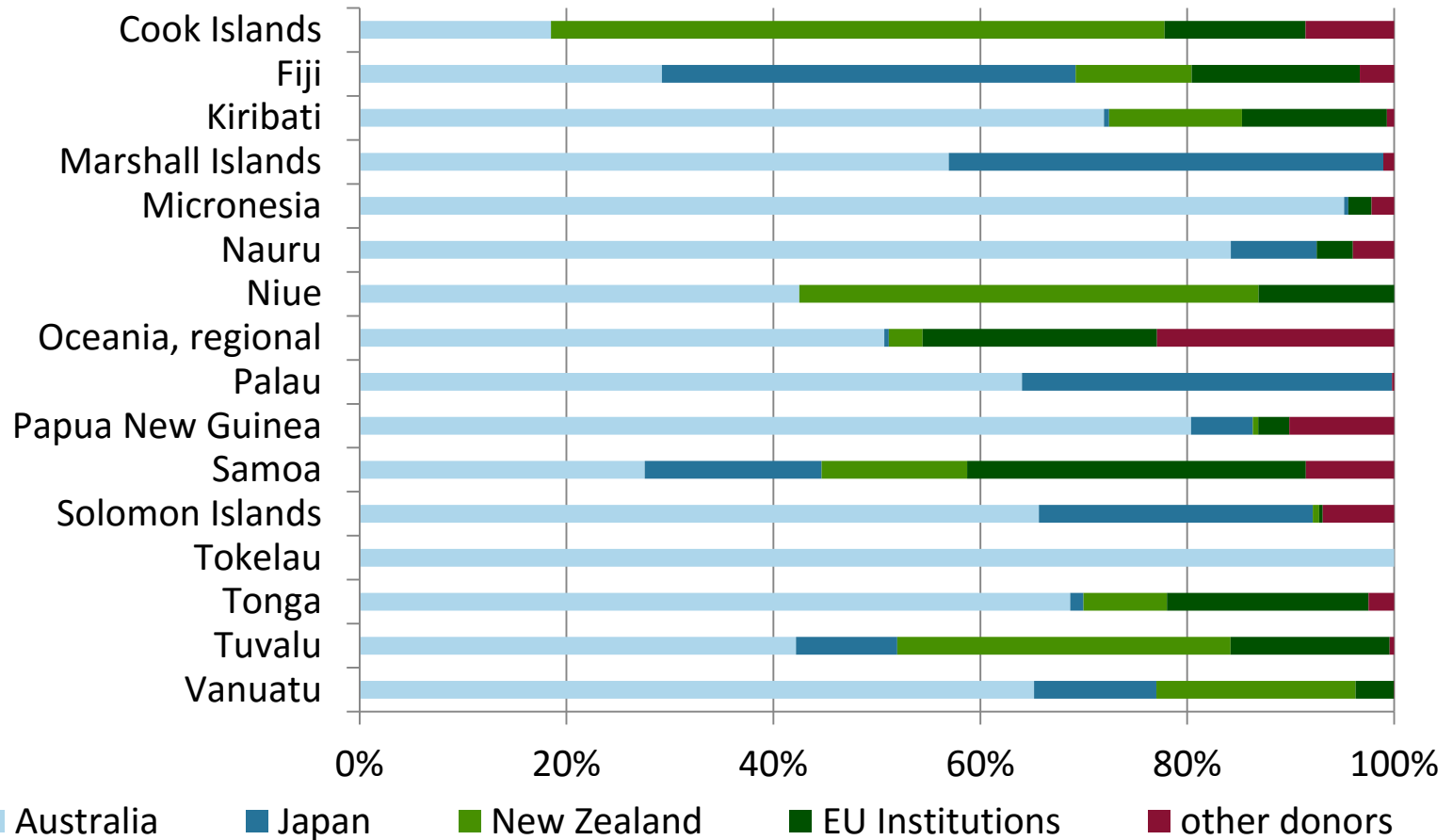

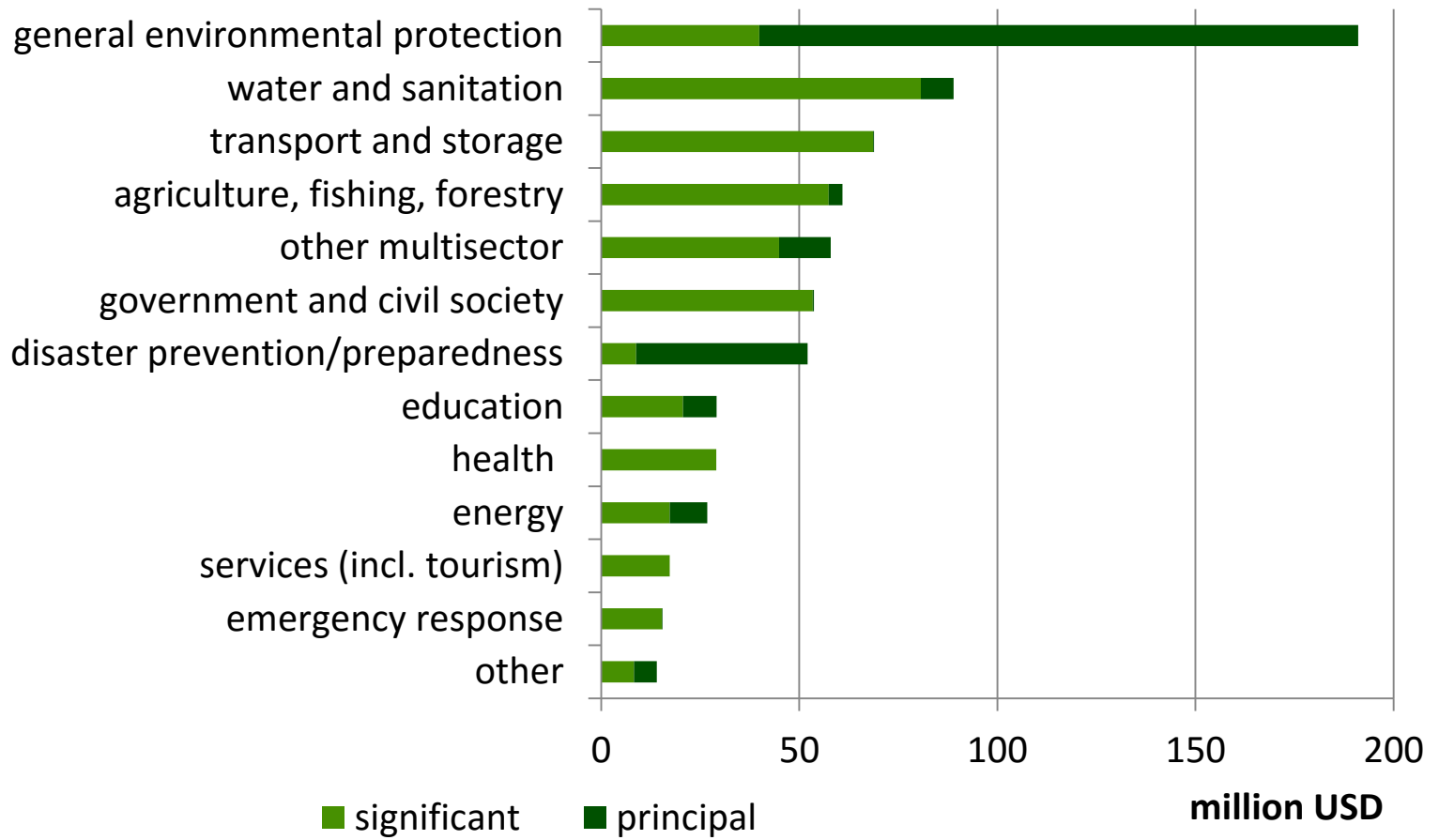
who gives adaptation aid to whom?

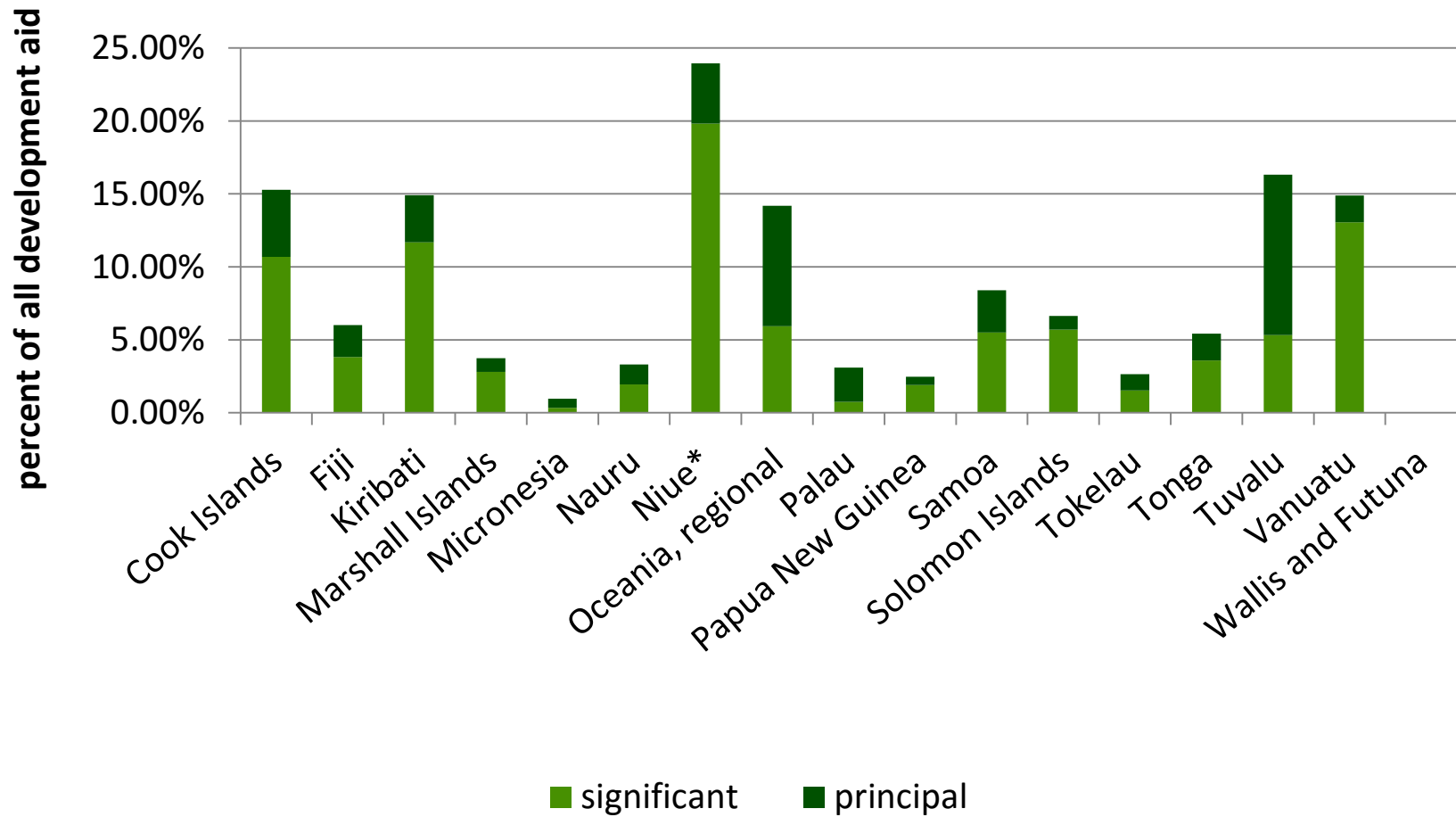


adaptation aid by sectors



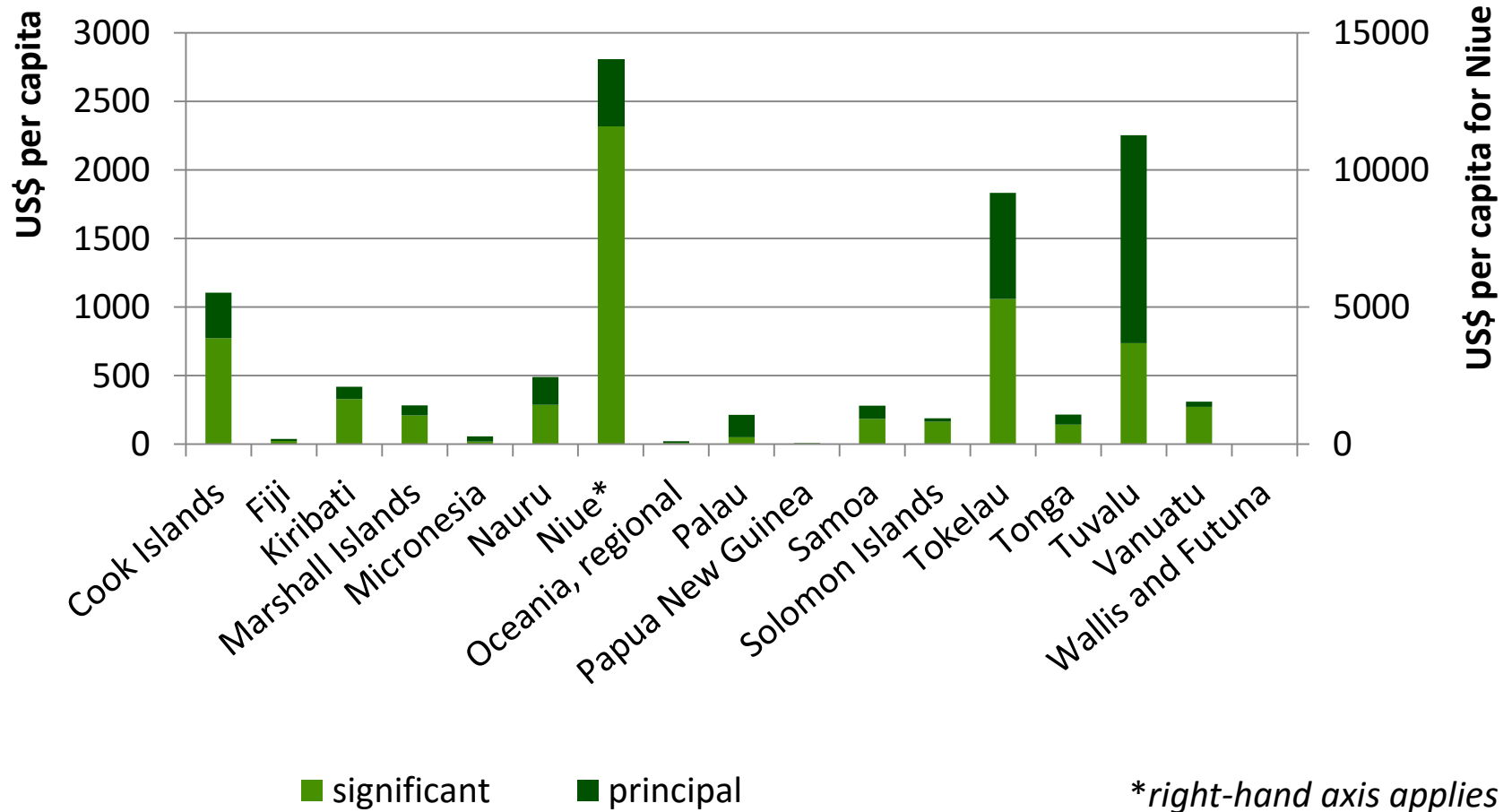
